


INVITATION FOR BIDS

 3. Bidding documents is available online and can be downloaded from e-GP system: www.bolpatra.gov.np/egp. Interested bidders shall register in the e-GP system and deposit the cost of bidding document in the following bank.

 6. Interested Bidders shall submit the electronic Bids through www.bolpatra.gov.np/egp, on or before **12:00 noon** on **2081/10/23** Documents received after this deadline shall not be accepted.

Bids will be opened in the presence of Bidders' representatives who choose to attend at Lamkichuha Municipality on **2081/10/23 14:00** hours at the office of Lamkichuha Municipality, Bids must be valid for a period of **90 days** after bid opening and must be accompanied by bid security, amounting to **2 to 3 % of the quoted Bid amount** (exclusive of VAT), which shall be valid for **30 days** beyond the bid validity period.
 8. If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in Deposit Account LAMKI CHUHA NA.PA. (GA-3)-DHARAUTI, AC Number 4450100303000002 Lamkichuha Municipality at Rastriya Banijya Bank., Lamki Branch, Kailali and submit bank deposit voucher along with the bid.
 9. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
