- 4. Sealed bids must be delivered to LamkiChuha Muniicipality, Office Of The Municipal Executive Lamki, Kailali, before 12:00 Noon 2075/6/16. Bids shall be valid for a period of 90 days after the deadline of bid submission. All bids must be accompanied by a bid security of amount mentioned below, valid 30 days beyond Bid validity. 7. Bank Guarantee issued by any finance company in any form will not be accepted.

- 8. Bids should comply in all respects with the Instructions to Bidder included in the Bid Document. Non compliance with this instructions will result in disqualification.
- 9. In the case of discrepancies or error in bid documents, bid notice or any other documents, Lamki ChuhaMunicipality, Lamki, Kailali reserves the right to amend and correct at any time.
